





Describe Circumstance of the Accident


ON 05/06/2023 @ 1026HRS, IT WAS CONGESTED DURING THAT HOUR. MY VEHICLE A (GBF3783Z) WAS STATIONARY ON LANE 3 ALONG UPPER CROSS STREET (RIGHT AFTER SOUTH BRIDGE RD TRAFFIC JUNCTION). SUDDENLY I FELT A HUGE IMPACT FROM THE REAR OF MY VEHICLE A. THE FORCE OF THE IMPACT PUSHES MY VEHICLE A TO COLLIDE ONTO VEHICLE C (EM8391R). I WAS SHOCKED AND SLOWLY ALIGHT TO CHECK AND FOUND OUT THAT VEHICLE B (GBH8665M) FRONT PORTION COLLIDED ONTO THE REAR PORTION OF MY VEHICLE A AND THE FORCE PUSHES TO HIT ONTO THE REAR OF VEHICLE C. WE ALL EXCHANGED PARTICULARS FOR INSURANCE CLAIM.


