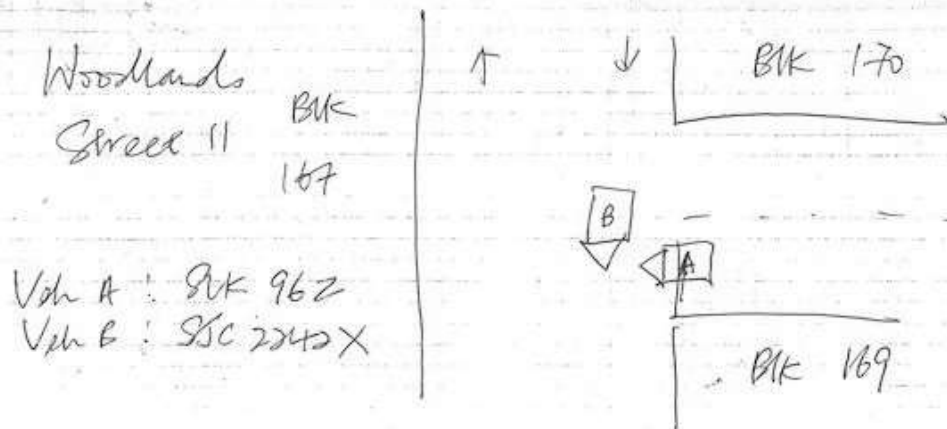

In a carpark at Woodlands Str. 11, I was at a small lane, joining the bigger lane. As I edged out at the stop line, Vehicle B and I collided.

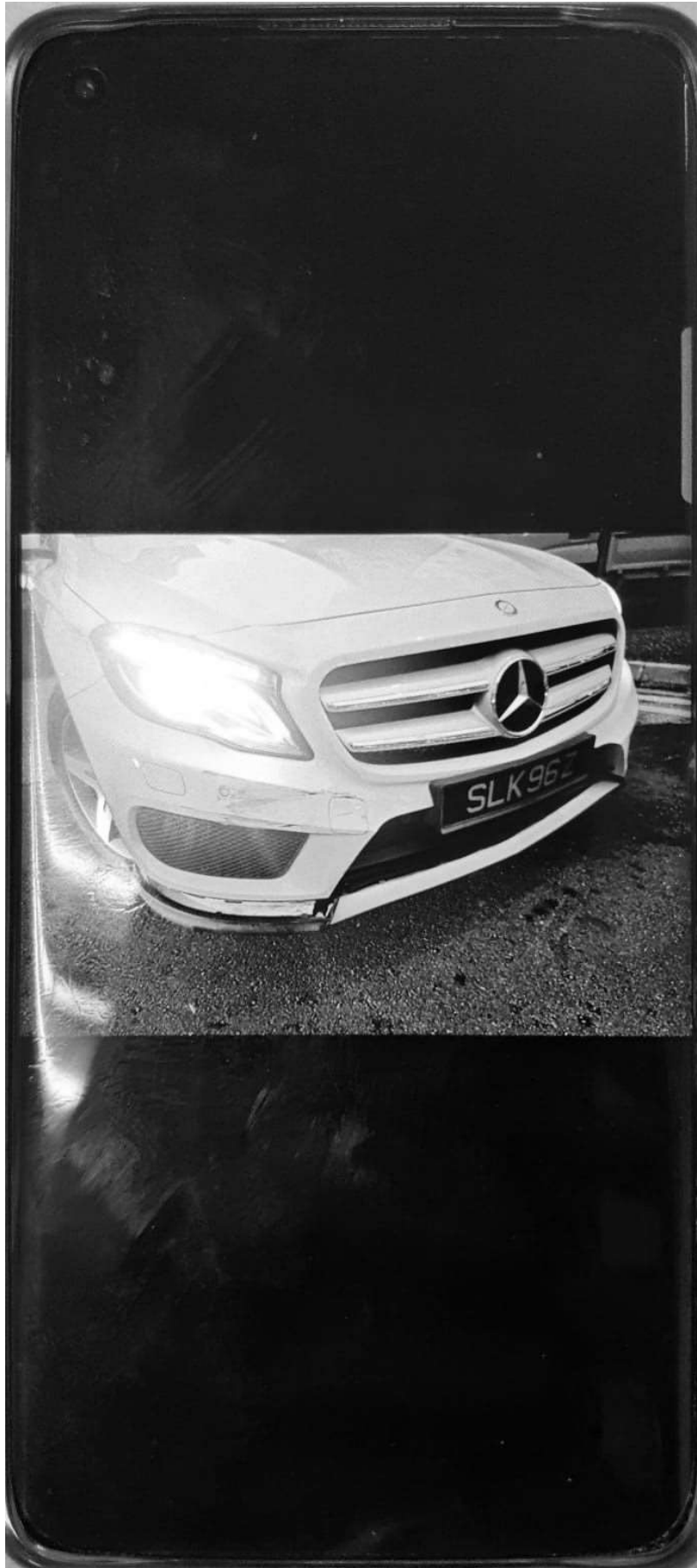

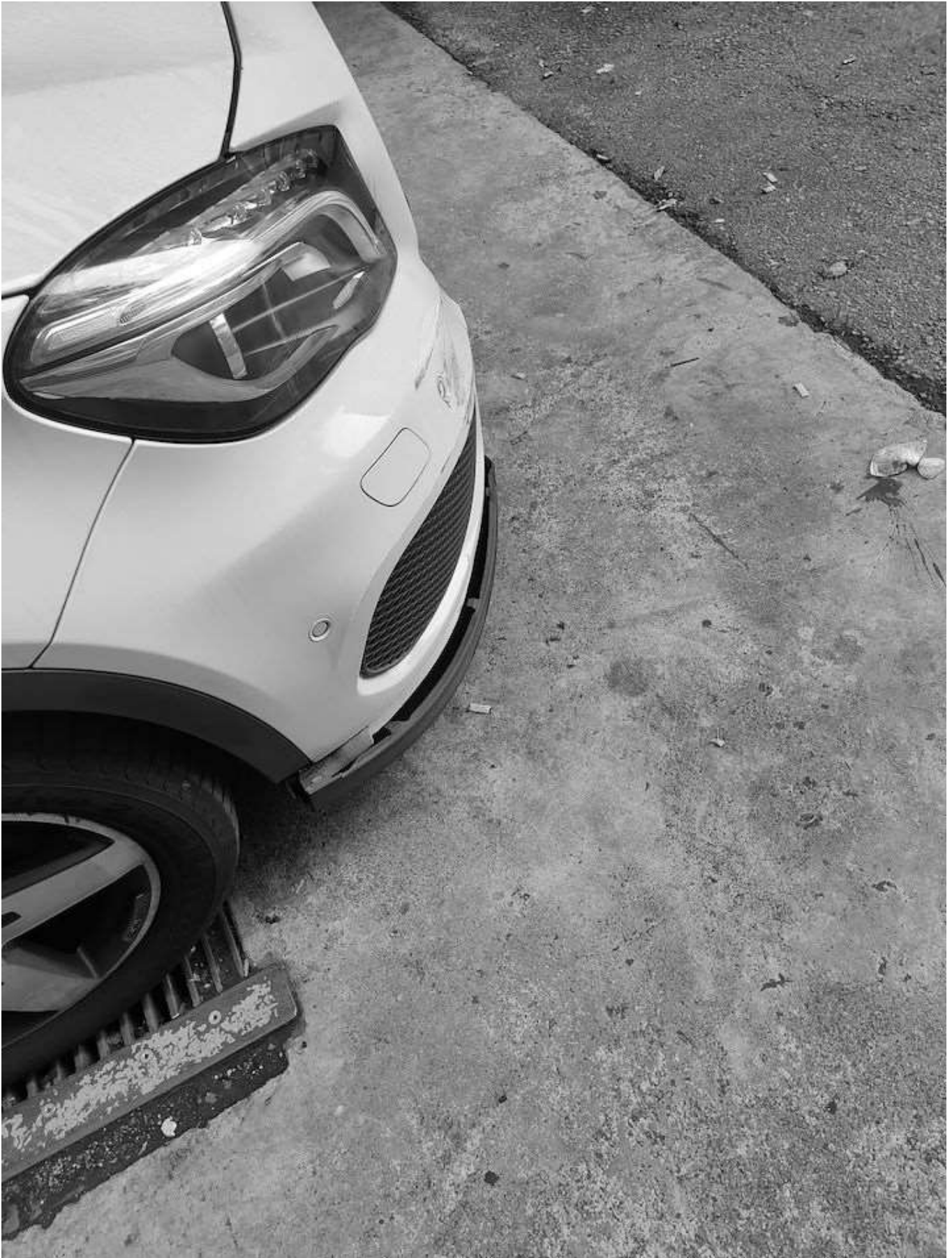
