

**Brief Details.**

On 04.06.2023 at about 1545hrs, I was driving SHA3939Y a Comfort blue taxi along Tampines Ave 1 towards Tampines Ave 10. At that time it was slightly drizzling. I was on the right most lane and was waiting for to u turn. I was waiting behind a Mercedes, SGW8848P. I was stationary when suddenly my car was hit on the rear on the right side. Due to the impact my car jerked forward and hit the car which was in front of mine. After everything came to a stop, I got out from my vehicle and found out that a van from the opposite direction had hit onto the green road divider and then hit onto my vehicle. The van's registration number is GBH1788M. I then called my company as well as both the ambulance as well as the police. When the ambulance came, I was then conveyed to Changi General Hospital. At that time I felt pain on the back of my neck, I felt breathless, nauseous and dizzy.

At Changi General Hospital, I was then given 3 days MC. I am unsure of the extend of damage to my vehicle and I also did not manage to exchange particulars with all parties. My taxi was towed away by traffic police. My taxi also has front and rear in car camera. That is all.
