Brief Details.

On 26/05/2023 at about 1300hrs, I was driving my blue coloured Hyundai Ioniq (bearing registration number SHA7686A) along ECP, exit towards Marine Parade. While I was driving through the bend of the exit, I suddenly felt an impact from the back and I lost control of my vehicle. As the vehicle behind hit onto the rear of my vehicle, my vehicle swerved and the front of my vehicle hit onto the road barrier. I then got out of my vehicle and discovered that the grey coloured Toyota van (bearing registration number GBK8932B) had hit onto the rear of my vehicle.

Due to the collision, the front hood of my vehicle was dislodged and was badly damaged. On top of that, my front bumper was also damaged. Due to the impact of the collision, I felt pain at the back of my neck and was feeling nausea. As I had a passenger in my vehicle, he then assisted me to call for ambulance. Shortly after, traffic police and ambulance arrived at scene. I was then conveyed to Raffles Hospital and was given 9 days MC.
