CIRCUMSTANCES OF ACCIDENT

AT APPROX 7.57AM ON 24 MAY 2023, I WAS DRIVING MY CAR SLP9510J ALONG CRESCENT ROAD (FROM MOUNTBATTEN ROAD IN THE DIRECTION OF DUNMAN ROAD). THE CAR SNE6258S WAS DRIVEN BY MS KIRANJIT KAUR DANG (DRIVING LICENSE S2171133J) ALONG WILKINSON ROAD FROM TANJONG KATONG ROAD. AT THE JUNCTION OF CRESCENT ROAD AND WILKINSON ROAD, CAR SNE6258S DROVE INTO CRESCENT ROAD WITHOUT STOPPING AT THE STOP-LINE ON WILKINSON ROAD. THIS RESULTED IN CAR SNE6258S HITTING THE RIGHT SIDE OF MY CAR JUST AFTER THE FRONT WHEEL, DAMAGING THE 2 RIGHT DOORS AND MUDGUARD. THE CAR SNE6258S FRONT BUMPER WAS DENTED. THE DRIVER WAS NOT INJURED. THERE WAS NO PASSENGER IN THE CAR.

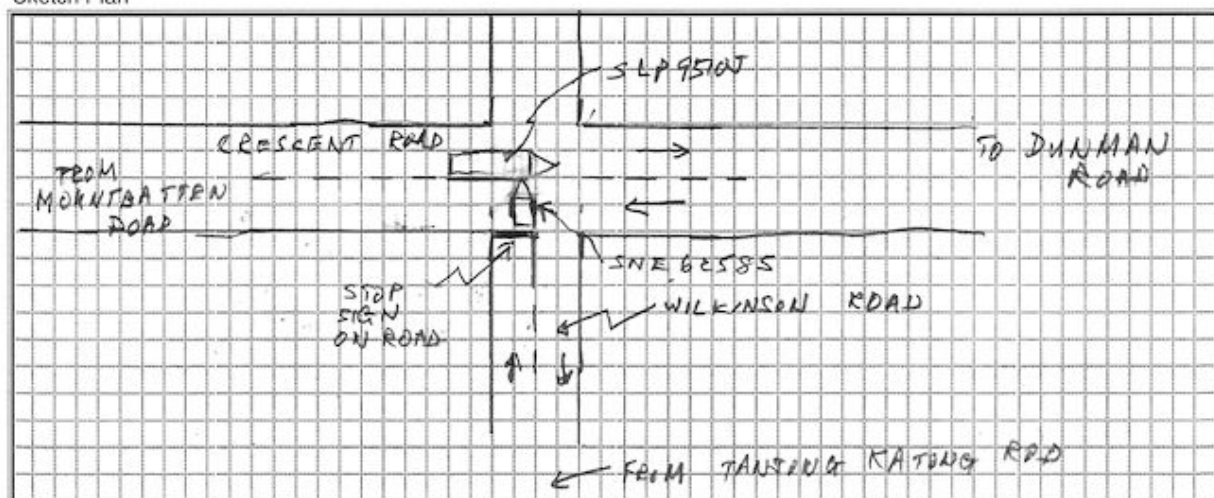

Describe Circumstance of the Accident

At approx 7.57am on 24 May 2023, I was driving my car SLP9510J along Crescent Road (from Mountbatten Road in the direction of Dunman Road)

The car SNE 6258S^{was} driven by Mr Kiranjit Kaur Jong (Driving License S2171133J) along Wilkinson Road from Tanjong Katong Road.

At the junction of Crescent Road and Wilkinson Road, car SNE 6258S drove into Crescent Road without stopping at the STOP line on Wilkinson Road.

This resulted in car SNE 6258S hitting the right side of my car just after the front wheel, damaging the 2 right doors and mudguard. The car SNE 6258S front bumper was dented. The driver was not injured. There was no passenger in the car.
