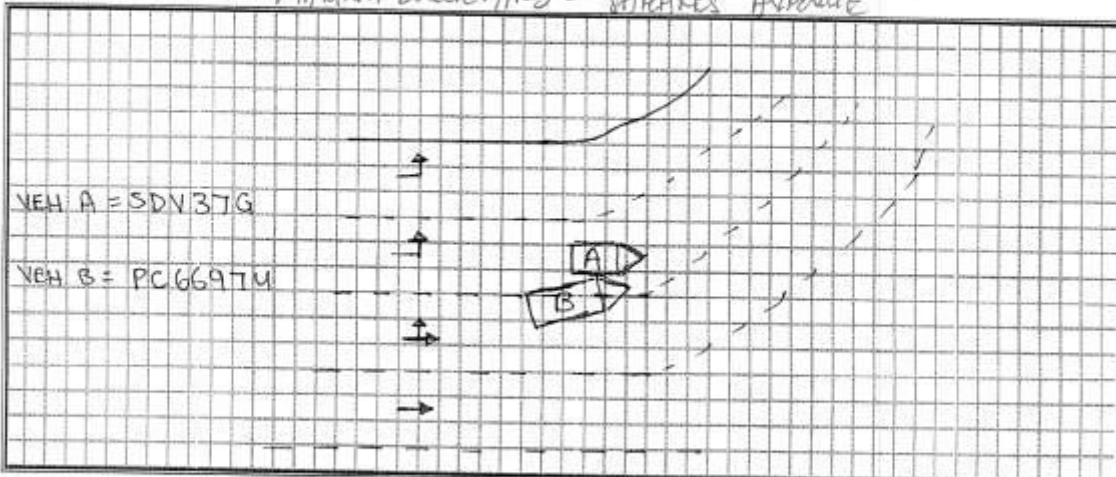

At about 12 pm on Wednesday 14 June 2023, my car (SDV37G) was on the second turning lane from Marina Boulevard into Sheares Avenue. Just before I turn, the bus (PC6697U) suddenly hit my car on the rear right portion of the car and the right rear rim was also damaged. I got a shock and as I am on the second lane, continuous traffic next to me and behind and the road in front was clear, instead of turning left, I have no choice but to veer towards Marina Boulevard to park at the left hand side of the road at Marina Boulevard, expecting the bus to do the same so that we could both look at the damage of our cars without causing a massive jam. When I stopped my car and get out, he did not follow me. I waived for him to drive straight to me but he just sat in the minibus and did not come down for a long while until the police arrived. At the instruction of the police, he moved his minibus forward to park at the side of Marina Boulevard in front of my car. The police took down both our details.
