Brief Details.

On 20/05/2023 at about 2010hrs, I was riding JVP4418 along Bukit Batok Street 25. I noticed a car from the opposite direction about to turn right entering the carpark of Blk 288 Bukit Batok St 25. As I was on the right of way, I continued cruising along the said road. Suddenly, the same car turned towards the carpark entrance and I could not brake in time to avoid collision. I hit onto the said car's rear left side and fell to my right side along with my motorcycle. I continued to lie down on the road and I felt pain throughout my hand and body. Shortly after, Ambulance came and I was conveyed to Ng Teng Fong Hospital. I suffered fractured Metacarpal bone and laceration on my left finger. I do not have any recording of the incident.

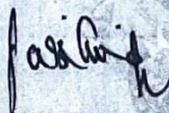
