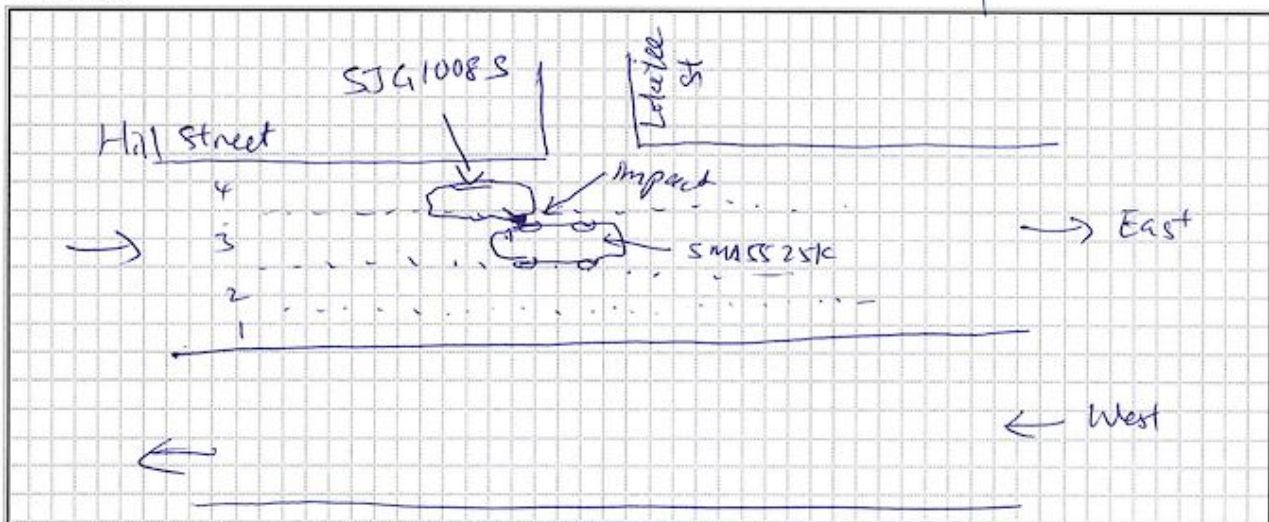

Describe Circumstance of the Accident

On 10 Jun 2023 at around 3:50pm, I, Lim Siaw Chay, driving vehicle SMA5525K, was driving along Hill Street East-bound. While approaching Lotce Yew Street on the left, there were no vehicles in front of me, while on the left was the vehicle ~~SFU~~ SSC1008S which was coming to slow stop as there was another car ahead of it. As there was no car in front of me, and there was no indication of change in direction of the car from the left, I continue my drive at a constant speed of around but below 50km/h. As I past by the Lotce Yew Street, I heard a sound at the back of my car, like an object hitting the car. So I slowed down and slowly pull towards side of the road. After I came out of the car then I realise the back left door of my car has a dent.
