8.30 PM ON 10 JUNE 2023

THE ACCIDENT HAPPENED ON CONVERGING LANE EXITING THE SENTOSA GATEWAY TUNNEL TO KEPPEL ROAD EXIT TOWARDS AYE VIA KEPPEL ROAD.

THE CAR IN FRONT CAME TO A STOP AS THE FILTERING LANE WAS PACKED DUE TO ONCOMING TRAFFIC SO CARS NEEDED TO WAIT TO FILTER INTO THE OTHER LANES. THE DRIVER NOTICED AND SLOWED THE CAR DOWN TO A COMPLETE STOP.

THE STATIONARY CAR FELT AN IMPACT FROM THE CAR BEHIND (SLZ1241K) WHICH PUSHED THE CAR (SKV186B) FORWARD TO HIT THE STATIONARY CAR IN FRONT (SLK7440S).
