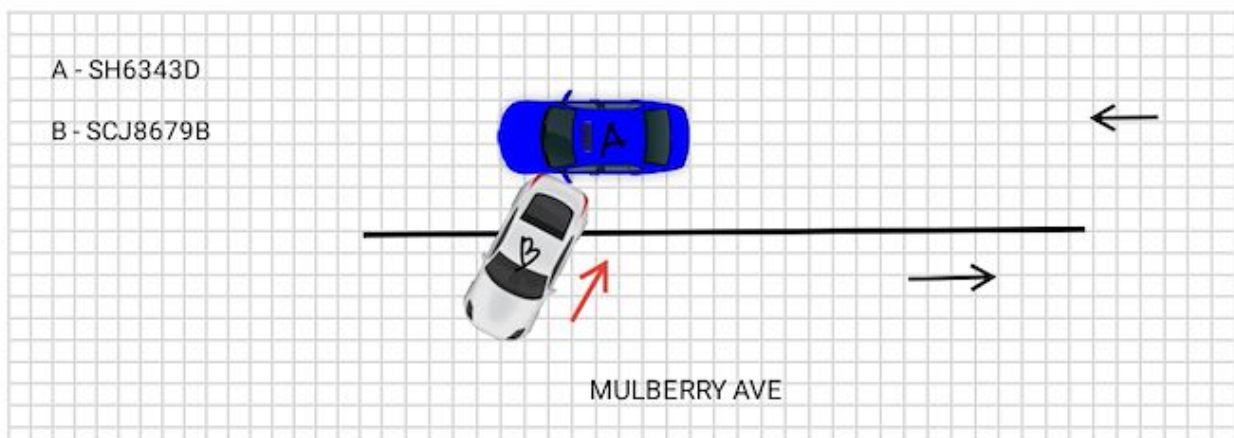

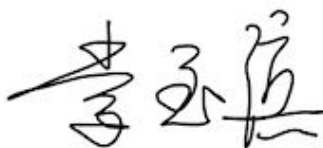
Sketch Plan
