

Describe Circumstances of the Accident

On the 17/06/2023 @ about 9.25a.m, along PIE(Changi).  
 I was travelling on lane 1 of the above mentioned  
 expressway after Whitley Road exit. When my front vehicles  
 slowed down and stopped, hence I followed suit. Suddenly, I  
 felt a huge impact from the rear, and the impact pushed my  
 Vehicle (A) forward to hit into Vehicle (D) in front of me. When  
 I alighted, I realised it was Vehicle (B) who hit into the rear  
 portion of my Vehicle (A), and there was a Vehicle (C) who  
 hit into the rear portion of Vehicle (B). It was a chain collision  
 of 4 cars in total. I have 2 other passengers in my car.
