


Figure A-2: MID41549 slows down upon the amber traffic light




Figure A-3: MID41549 came to a complete stop at the stop line. GBA3842M continued accelerating




Figure A-4: GBA3842M rear-ended MID41549




Figure A-5: MID41549 moved forward from the impact

Upon seeing the junction, I ease off my accelerator and gradually apply my foot brake at the same time my VC also acknowledged and reminded me to slow down. The traffic light that was to my favour changed to amber and I managed to come to a stop. Few seconds later, a tyre screech was heard and I was rear-ended by a civilian vehicle. My vehicle went over the stop line and into the pedestrian crossing. None of the us and the 3rd party was injured however I was put in a state of shock upon the accident. Around 1100hrs, my Node Sergeant Major, 3WO Agilan, came and assessed the situation. After




Figure D-6: Amended Police Report of PTE JAZLAN Part 3


