Brief Details.

On 07/02/2020 @0640hrs I was driving my COMFORT taxi along Bukit Panjang Ring Road. As I was about to turn into Senja Link at the T-junction, I heard a vehicle sounding its horn. I am not sure which vehicle had sounded its horn or for what reason. As I was startled by the sound of the horn. I did not pay attention to the traffic light at the said T junction before proceeding to make the right turn into Senja Link. As I was making the right turn, I saw a motorcycle travelling towards Bukit Panjang Ring Road and in the direction of my taxi. As I was already in the midst of making the right turn I was unable to pass the motorcycle in time and the motorcycle collided onto my taxi's front. I then immediately stopped my vehicle and attended to the rider, a male Malay who seemed unconscious at that time. I then called for the Police. The ambulance subsequently arrived at the accident location and conveyed the rider to the hospital. I wish to say that I was not injured in the accident however both my taxi and the motorcycle suffered serious damage. No government property was damaged in the accident.
