DRIVING ON 1ST LANE (RIGHTMOST) ON PIE TOWARDS CHANGI AIRPORT NEARING THE EUNOS EXIT FRONT CARS SUDDENLY BRAKED HARD.

I EMERGENCY BRAKED ALONG WITH THE FRONT CARS, COMING TO A STOP FROM ABOUT 80KM/HR.

I WAS SUBSEQUENTLY REAR-ENDED BY THE PASSENGER CAR FROM THE BACK BY ANOTHER PASSENGER CAR.

THERE WAS A SIGNIFICANT IMPACT AND MY CAR AT A COMPLETE STOP LURCHED FORWARD A DISTANCE OF ~ 1 METRE.

THERE WAS NO SUBSEQUENT IMPACT OF THE CAR IN FRONT.

Describe Circumstances of the Accident

Driving on 1st lane (right most) on PIE towards Changi Airport
 Nearing the Lums exit front car suddenly braked hard.
 I emergency braked along with the front cars coming to a stop
 from about 80 km/hr.
 I was subsequently rear-ended by the passenger car from the back
 by another passenger car.
 There was significant impact and my car at a complete stop lurched
 forward a distance ~1 metre.
 There was no subsequent impact of the car in front.
 Accident occurred approximately 0821-0822 hours.
