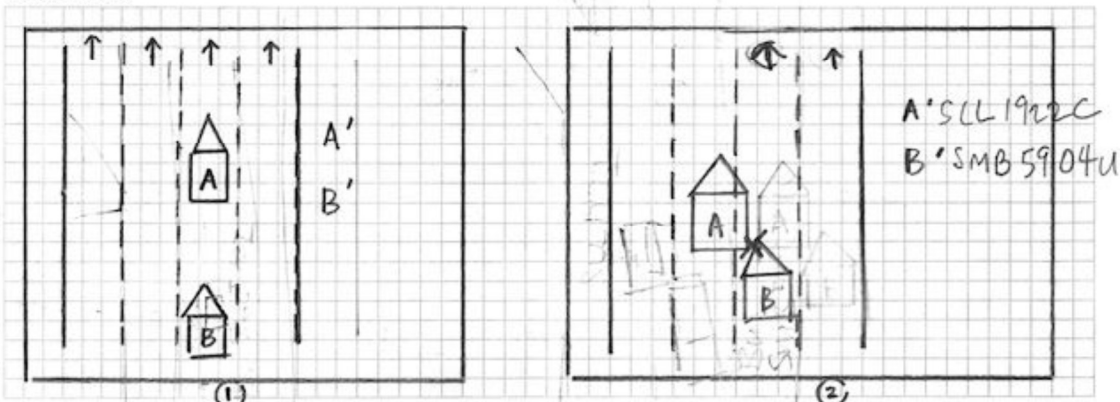

## Describe Circumstances of the Accident


I was driving along BKE in the direction of exit to SLE.
