

Brief Details.

Was driving along AYE towards City, heading home. Before the 90 mph speed limit camera, a blue Hyundai Avante came into my lane. Since then traffic was slow moving, often breaking and slowing down. I was not sure why, I could not see what was happening in front of the blue Hyundai Avante car.

Since then was happening I slowed down and gave myself as much distance as I could from the Blue Hyundai Avante. Till somewhere close to the flyover (Not sure which one), probably about 1KM away from the Alexandre road exit where I usually take to exit home. The blue Hyundai Avante suddenly break/jam break because it seems like the car was not moving at all, seeing that, I break my car too. Thankfully I was able to break in time, and shortly after accelerate again.

In quick succession, I heard a very loud bang behind me. I thought I got hit by a car, but looking through my rear mirror for like 1-2 seconds, I suddenly felt a strong push forward and by then realized I was hit by the car behind me. I did not get out immediately, I cruised forward a little bit and calmed myself for like 15 seconds before heading out.

Came out to check the damage to my car, and saw the car behind me driver came out and was on the phone. I walked to him and asked him if he was ok and if he was calling the ambulance or the traffic police, he told me the ambulance so I called the police. I then realized he had family in the car while I was on the phone, they were in distress and clearly shock from the ordeal. I walked to the back of the car and realized the extensive damage that was done. It was unusable in my opinion. Very badly damaged. Thankfully the family was not in any critical condition.

I saw the damage to the 3rd car and realized it was totally totaled. Explains the damage to the car that was behind me, it seems to me that he was speeding and could not stop in time or did not stop. The driver of the 3rd car did not come to speak to us or even asked if we were ok, he just stood there for a good 20-30mins while we waited for the authorities to come. I believe the only person he called was the car rental company owner who was present on the scene,

This is all I have to say that is relevant to the incident.
