

Describe Circumstance of the Accident

At around 3.35pm on 25 June 2023, I was travelling along Ubi Ave 2 in my car, SNA6074B, on the way home. At the junction of Ubi Ave 2 and Ubi Rd 1, I was waiting at the traffic light and saw the vehicle, SCR20R, turn into Ubi Ave 2 and travelling ahead. When it was green light for me to proceed, I was travelling at about 40-60km/h, which was within the speed limit. As I was approaching the front of Blk 3021, I saw the said vehicle about 100m in front of me. However at that time, I momentarily looked away and when I looked back in front, I was shocked to see the said vehicle very close, what seemed to me it was either stationary or moving very slowly, so I immediately braked hard and tried to swerve right. Unfortunately there was not enough breaking distance and my vehicle collided to the rear of the said vehicle. The said vehicle was a 'L' plate vehicle with the learner at the wheel. All of us exited our vehicles and ascertained that no injuries were sustained by any parties. We exchanged personal particulars and I departed from the scene.
