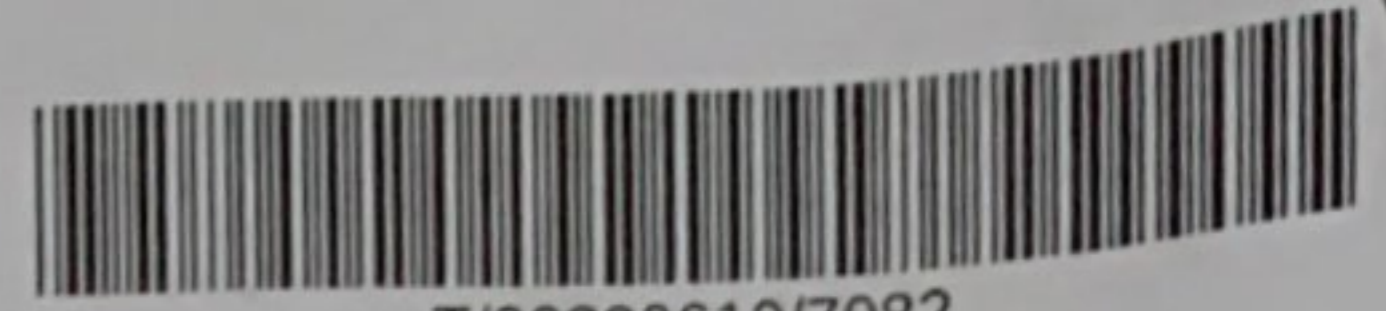

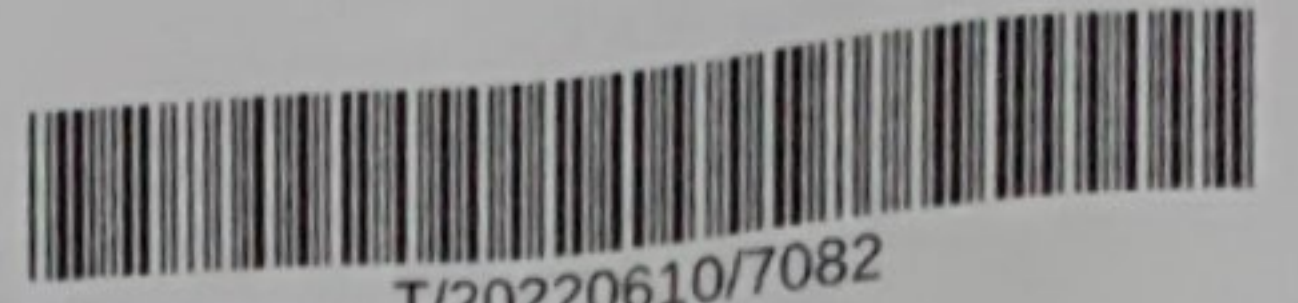

CONTINUATION OF REPORT

Brief Details.

On the above mentioned date and time, I was at a traffic light along Yishun Avenue 1 heading towards the SLE expressway to Sengkang. The traffic was heavy at the time. When the light turned green, as I was about to move my foreign vehicle bearing plate (JSN1170), the car behind me bearing the plate (SMV6871T) suddenly crashed head on into my rear bumper, and my car subsequently crashed on the van bearing the plate (GBA2714G) in front of me. After the accident took place, the driver that crashed on my rear bumper explained that he did not managed to brake in time as the van (GBA2714G) had suddenly stopped. After a short while the Traffic Police came to the scene. I suffered a minor injury in the accident and my vehicle was seriously damaged. I was not conveyed to the hospital. I went to a Lion Health Clinic & Surgery located in Yishun Central afterwards, and the doctor gave me 3 days of MC. The Medical certificate number is (04639, #766).
