SKETCH PLAN




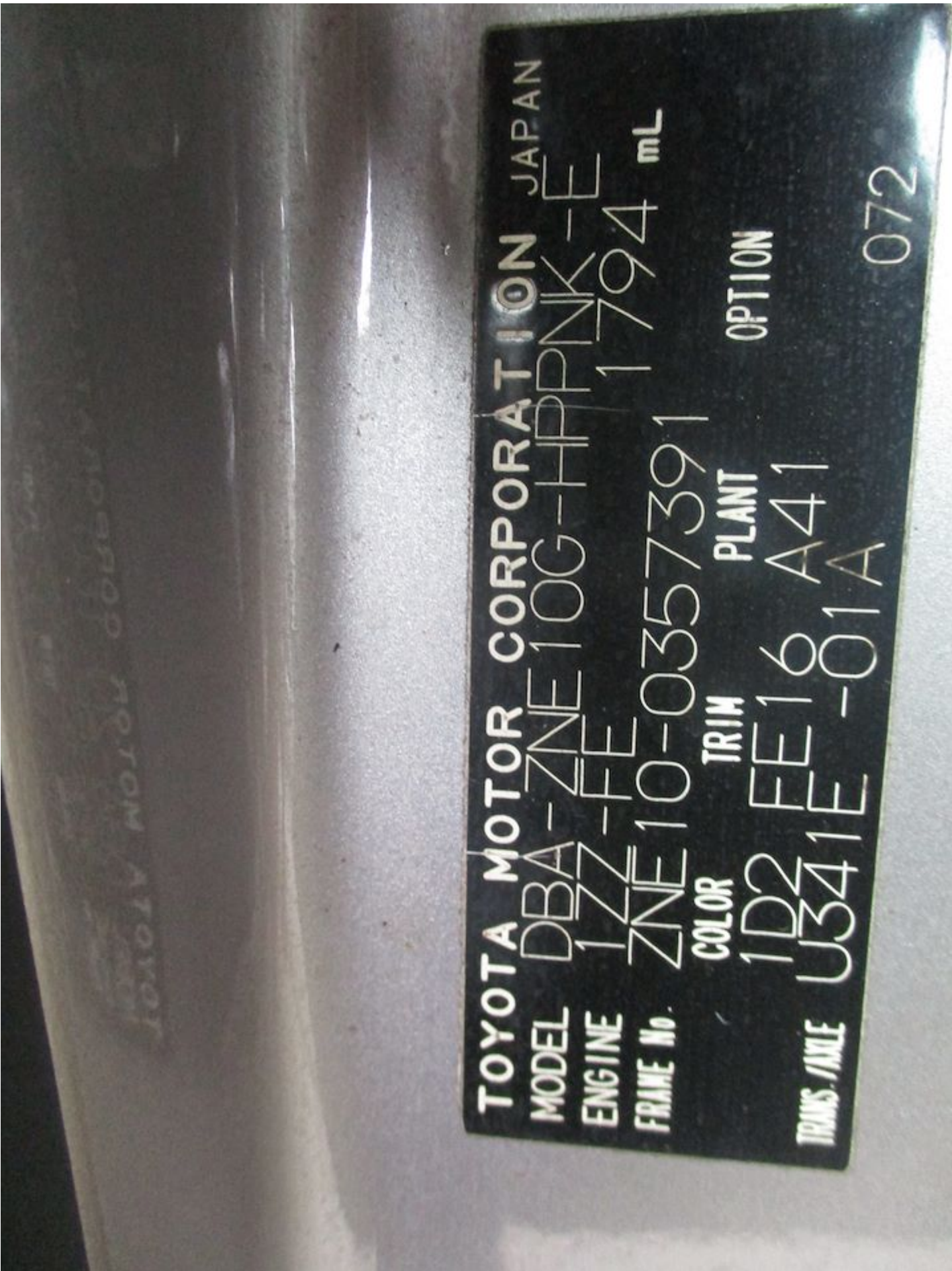
