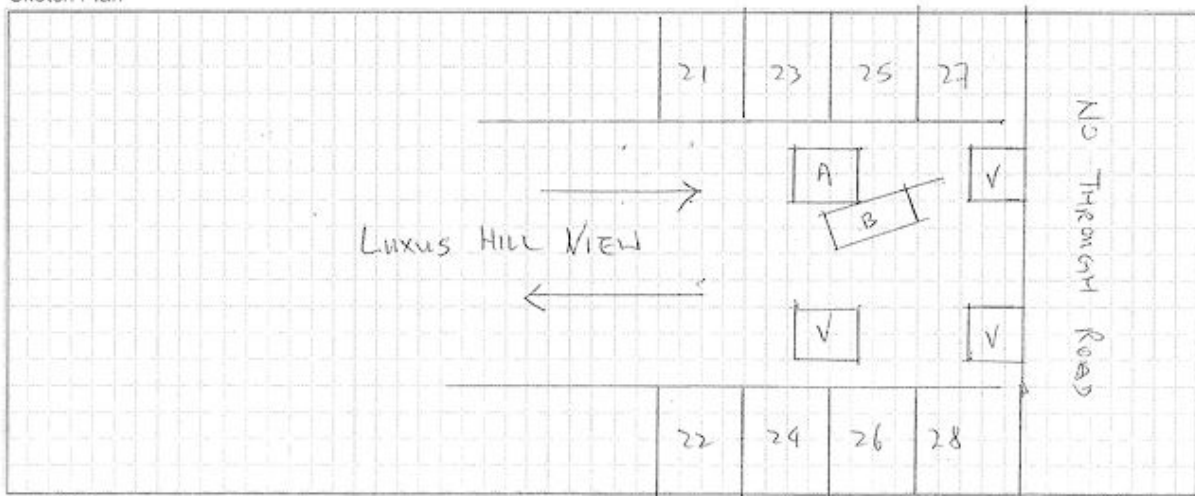

Describe Circumstance of the Accident

I am the owner of SKODA OCTAVIA SBV6476G. On 25 June 2023 my vehicle (SBV6476G) was parked outside 25 Lulus Hill - alongside 23 Lulus Hill View and 25 Lulus Hill View and my vehicle was stationary.
