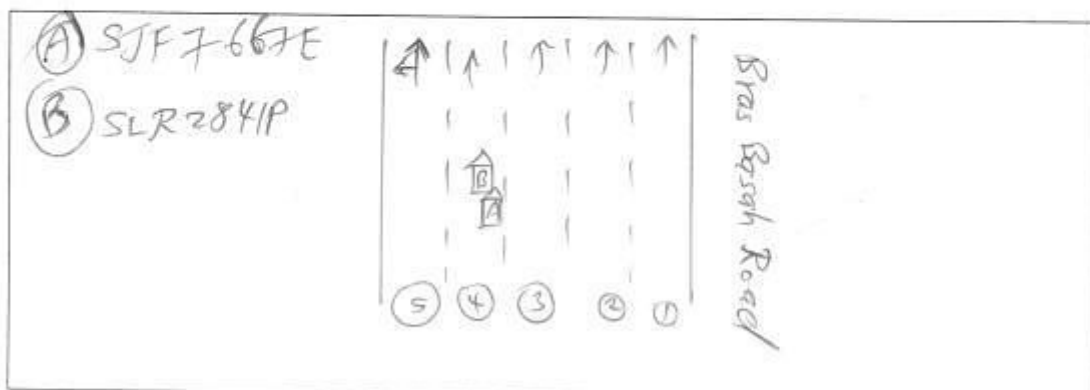

**Sketch Plan**















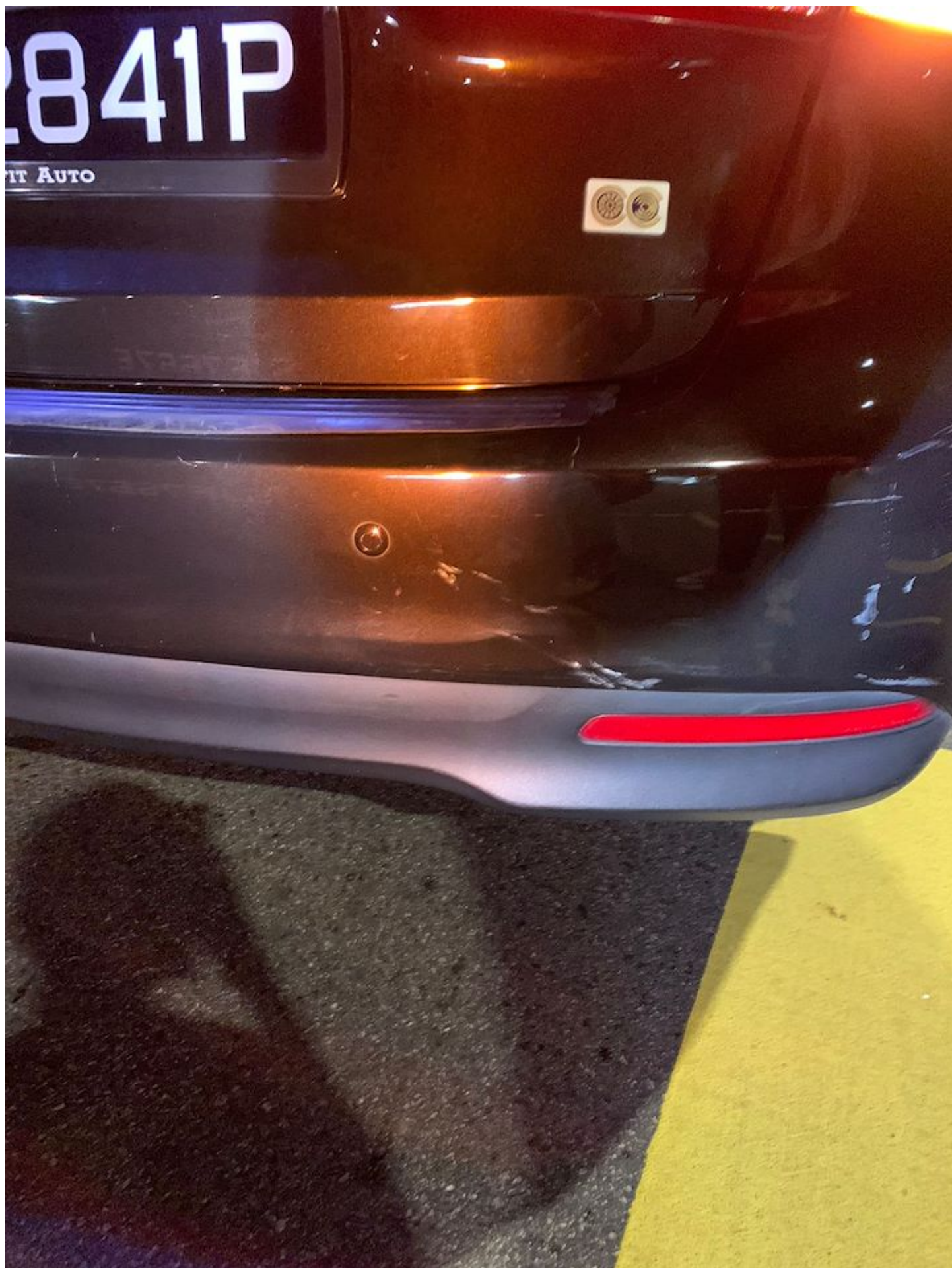
