Describe Circumstances of the Accident

Drove off on the middle lane. 3 cars was involved in an emergency brake collision as one car (SFM8008L) braked suddenly to make a last minute right turn from the middle lane. The first car managed to brake in time (SKX8Y) but was bumped by the second car (SMH 362J). I saw the second car (SMH 362J) brake but since the light on the traffic was green, it did not register that he was performing an emergency brake. By the time I floored the brake, it was too late and hit the second car (SMH 362J). The car that made the illegal turn (SFM8008L) did not get hit and drove off and made the right turn after that.
