

On 29 June 2023, at about 1751hrs, I was traveling in my vehicle, White Honda Odyssey, car plate number SMT2821A, along Joo Koon Circle towards Benoi Road, on the extreme right lane at about 45-50km/hr.

When approaching the pedestrian traffic light in red, at bus stop Joo Koon Circle B01, I stopped my vehicle behind the white line, on the extreme right lane. A vehicle number YN6162G suddenly collided on to my rear and caused damages (refer to the photos attached)

I immediately checked on my 8 months old infant and my helper. There were seen no visible injuries at that point of time, except my 8 months old infant was crying due to the sudden shock.

The driver was remorseful and apologized of his carelessness. The driver contacted his manager and the manager arrived soon after. His manager, Mr Yong Jian, apologized on behalf of his staff and claimed that his driver may have lost his concentration onto the road while using his mobile phone as they were rushing.
