## CIRCUMSTANCES OF ACCIDENT

PLEASE REFER TO POLICE REPORT NO, T/20230627/7097 LODGE AT 10 UBI AVENUE 3
I WAS TRAVELLING ON THE ACCELERATING LANE TO ENTER SLE TOWARDS CTE FROM WOODLANDS AVE 2.THERE WAS A SLOW TRAFFIC BUILDUP TO ENTER WOODLANDS AVENUE 12. TO MAINTAIN A SAFE BRAKING DISTANCE I HAD TO SLOW DOWN TO APPROXIMATELY 40KMH, THEN A STRIDES SMRT TAXI SHB1868B ABRUPTLY CUT IN-FRONT OF ME AND SLOWED DOWN TO JOIN THE QUEUE FOR WOODLANDS AVENUE 12 EXITS, TO AVOLD THE COLLISION, I HONKED CONSTANLY AND STEERED TO THE LEFT SIDE OF THE LANE BUT THE TAXI DRIVER DID NOT GIVE ANY ROOM TO MANOEUVRE AND SIDE SWIPED ME, I HAD NO SPACE TO MANOUEUVRE AS THRERE WAS A LARGE TRAILER ON THE NEXT LANE AND THERE WAS NO ROAD SHOULDER ON THE LEFT SIDE OFTHE ACCELERATING LANE. THE DRIVER, TAN KIM SOON, CLAIMED THAT HE DID NOT SEE ME WHEN HE WAS LANE CHANGING. THIS INDICATES THAT HE DID NOT CHECK HIS SIDE VIEW MIRRORAND LEFT BLINDSPOT WHILE LANE CHANGING. 

## **Brief Details**

I was travelling on the accelerating lane to enter SLE towards CTE from Woodlands Ave 2. There was a slow traffic buildup to enter Woodlands Avenue 12. To maintain a safe braking distance I had to slow down to approximately 40km/h.

Then, a Strides SMRT Taxi (SHB 1868 B) abruptly cut in-front of me and slowed down to join the queue for Woodlands Avenue 12 exit.

To avoid a collision, I honked constantly and steered to the left side of the lane but the taxi

driver did not give me any room to manoeuvre and side swiped me.

I had no space to manoeuvre as there was a large trailer on the next lane and there was no road shoulder on the left side of the accelerating lane.

The driver, Tan Kim Soon, claimed that he did not see me when he was lane-changing. This indicates that he did not check his side view mirror and left blindspot while lane changing.

I have photos regarding the incident and the accident did not take place at a pedestrian crossing.
