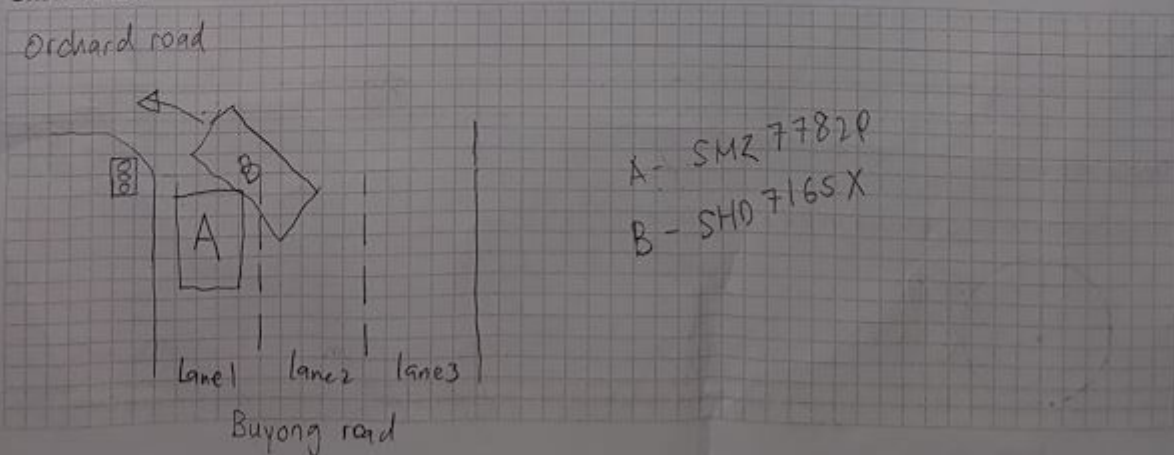

### Sketch Plan






**Describe Circumstances of the Accident**

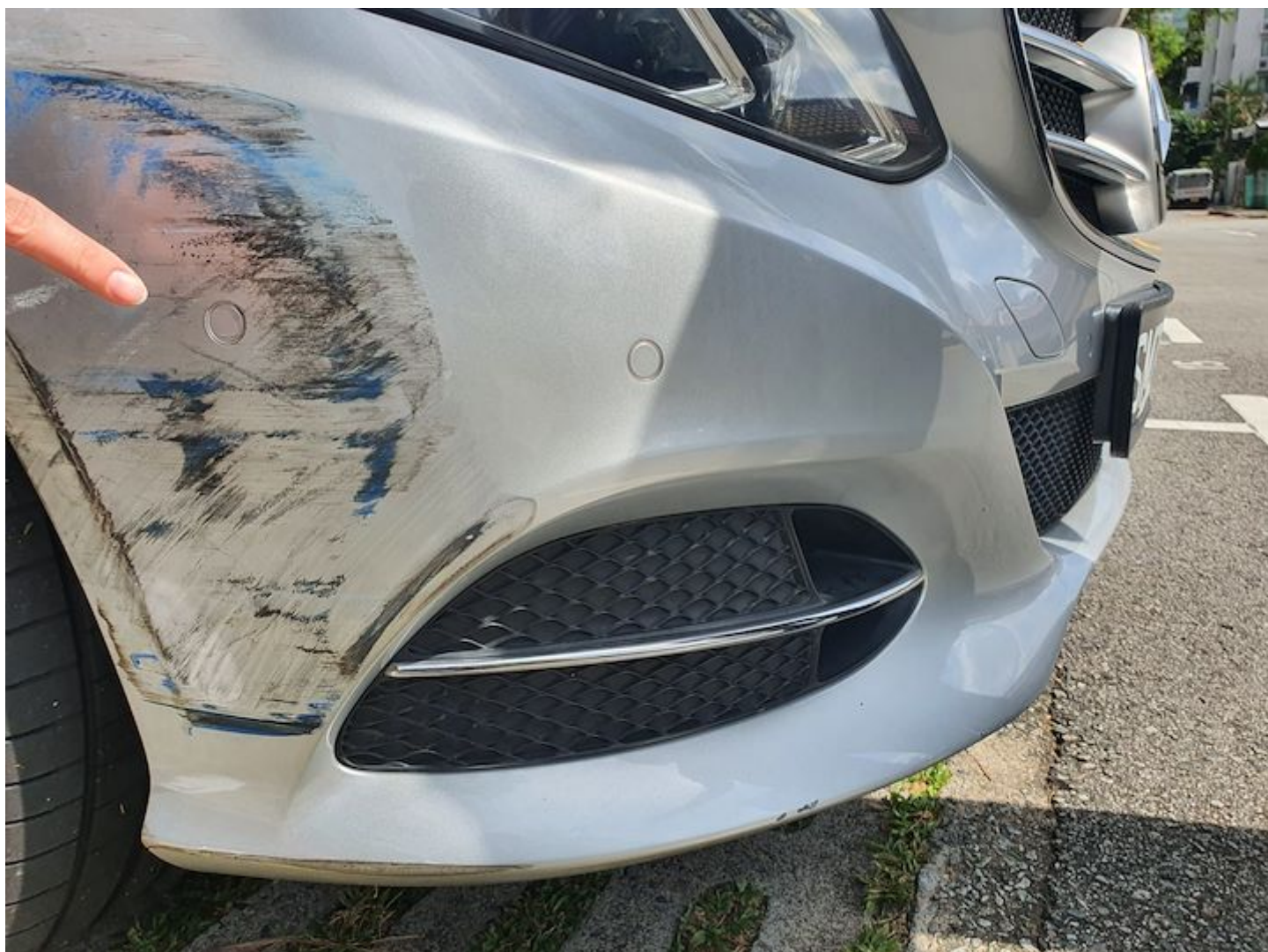


