

3. Report the accident, with your Vehicle (whether damaged or not), to one of our Approved Workshops listed below within 24 hours or by the next working day.
4. Lodge a police report if the accident involves:
 - injury;
 - a hit-and-run situation;
 - damage to government vehicle or government property;
 - foreign vehicle;
 - pedestrian or cyclist.
