On June 1<sup>st</sup> 2023, at approximately 12:45pm, I was dispatched to Selangor Camp in a F550 Combat Ambulance with CFC Jasper as my vehicle commander. Along exit 7A, TPE to Changi, I was making a lane switch to the left. As usual, I will practice defensive driving and checking my blind spots before lane changing. After observing both my left and right mirror clear of moving vehicles, I gradually change lane to the left after signalling while observing my blind spots. After completion of lane changing, CFC Jasper alerted me that there was bus near proximity. I acknowledged but I did not feel any impact at that point of time. CFC Jasper then alerted our commanders of the situation and we proceeded straight to Selangor Camp.
