Brief details.

On 7 July 23 at around 0715hrs, I was driving RSAF Minibus (MID 46310) together with my Vehicle Commander Ayden See along Jln Boon Lay towards Jurong Island for a duty crew swop driving task. The incident happened along Blk 263 Boon Lay Drive bus-stop number (21379). At that point in time, I was at lane two travelling forward, while there was a civilian vehicle (Grey Mazda 3 SMU9546T) in front of me trying to perform a lane change from lane two to lane three. As he came to a stop in the middle of both lanes, I tried to brake my vehicle but felt a resistance on the brake pedal. I proceed to step even harder, which resulted in my foot slipped off and went off the brake pedal. This caused my mini-bus to collide with
