

ON 11/07/2023 AROUND 2350HRS I WAS DRIVING VEHICLE A (SHC2042E) ALONG ROCHOR ROAD TOWARDS BUKIT TIMAH AT THE JUNCTION OF JALAN BESAR I WAS TRAVELLING STRAIGHT ON LANE 3, SUDDENLY THERE WAS THIS VEHICLE B (SNE7196E) MAKE A RIGHT TURN FROM LANE 2 AND COLLIDED ONTO VEHICLE (A) FRONT RIGHT PORTION AND THE IMPACT MADE MY RIGHT DRIVER SIDE DOOR STUCK.
