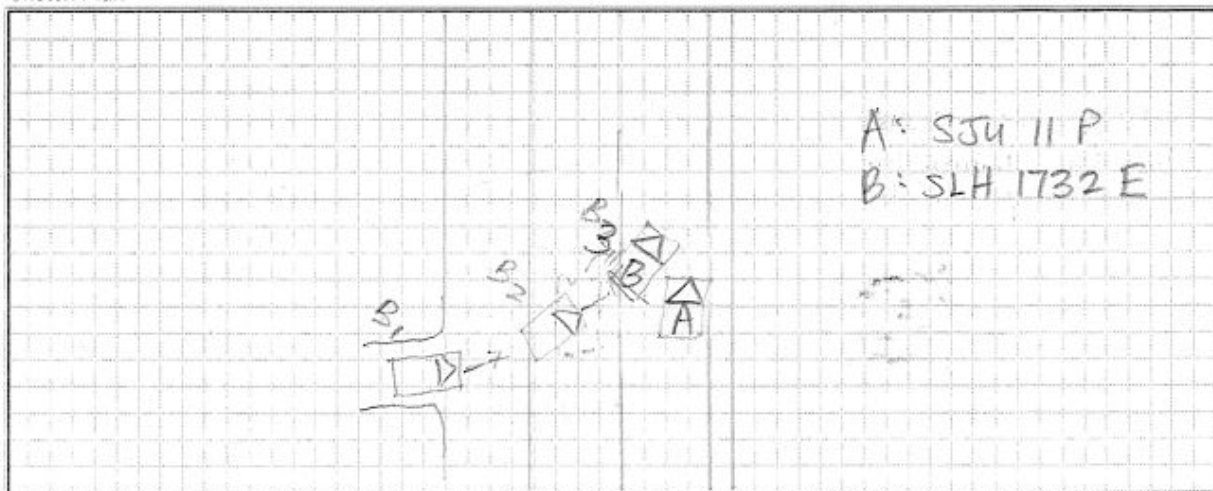

Describe Circumstance of the Accident

On 7/7/23 at about 10pm, I was travelling from my office at Ubi heading towards Long Chuan to meet my family. I was along Bunday Road when I saw a dark vehicle exiting the car park from the left hand side and I immediately slowed down and sounded my horn to let the car know I was approaching.

As you can see from the video, the car did not make her directions clear as there was no signal light. Furthermore, she exited the car park directly into the middle lane in a 3 lane road.

In order to avoid her, I had 2 choices - either the left or the right lane and decided on the latter while still <sup>honking</sup> her to let her know of my incoming presence. From the video, you will notice that I kept in the middle lane for a moment but suddenly decided to inch out to the most right lane without signalling and that was when I jammed brake as I was being forced into a corner. Unfortunately, it was too late as the distance between my car and hers was much closer as compared to earlier.

To make matters worse, just before the point of contact, she decided to brake and stop her vehicle in the middle of 2 lanes, leaving me absolutely no room to avoid her.

It is obvious that she was totally oblivious of her surroundings in spite of my incessant honking. In fact, she had no reason to <sup>immediately</sup> cut 3 lanes upon exiting the car park as the road in front of her was clear, which provided her ample time to filter lane by lane to the RHS, as the traffic light was for ahead. As a result of the above, her right side of her vehicle collided with the left side of my vehicle. The front right rim of my vehicle was damaged as I was ~~squeezed~~ squeezed right to the end of kerb, in my attempt to avoid the other car.
