The above-mentioned vehicle was deregistered on 20 May 2023. If the vehicle is yet to be disposed of, you should do so by 20 Jun 2023. Scrap it (including the engine and chassis) at an LTA-appointed scrapyard or submit to LTA documentary proof that the vehicle has been permanently exported out of Singapore. Otherwise, it is an offence and the penalty is a fine of up to \$2,000 and imprisonment of up to 3 months for the first offence. Subsequent offences carry heavier penalties.

DESCRIPTION OF DAMAGES

The vehicle sustained a severe impact damages on the front portion resulting the front headlamps, bonnet, fenders, bumper, support panel, air con condenser, radiator, oil cooler, wheel rim RH, undercarriage, engine mountings, engine block, chassis members and etc were badly dented/deformed/cracked/broken. Many other parts also affected.

VEHICLE VALUE

We have checked the vehicle pre-accident average market value, as at the time of accident is about \$\$182,800.00 (One Hundred Eighty-Two Thousand Eight Hundred Only). COE rebate is about \$\$41,569.00 (Forty-One Thousand Five Hundred And Sixty-Nine Only) and PARF rebate amount is \$\$18,071.00 (Eighteen Thousand And Seventy-One Only) eligibility.

Therefore, the average market value of S\$182,800.00 less S\$59,640.00 balance liability will be about S\$123,160.00 (One Hundred Twenty-Three Thousand One Hundred And Sixty Only).

COST OF REPAIR

There is no estimate submitted by the repairer. Due to the damages sustain, in our opinion, it is deemed to uneconomical to repair this vehicle and is to be treated as Total Loss.

Our estimated loss tabled above does not include provisions for towing fees and garage charges.
