Somewhere near a pedestrian crossing (traffic lights junction) as a traffic lights were green in my favour, I continued ride. Before I could reach the said traffic lights junction, a motor car no. SKV 1402X which was travelling along the middle lane of the bishan Road suddenly swerved left and thus collided into the right side of my motorcycle. The impact caused myself to be flung and fell on the road.

As a result of the accident, I sustained fractures over my right leg. I therefore conveyed by an ambulance

to Tan Tock Seng Hospital for treatment.
