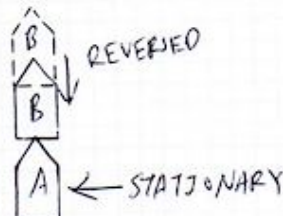
Sketch Plan

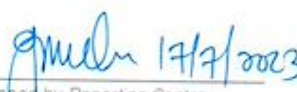
