I WAS DRIVING BUS REG. NO. SMB5014M AT THE STATED DATE AND TIME. MY BUS WAS STATIONARY AT THE TRAFFIC JUNCTION OF SERANGOON ROAD. WHEN TRAFFIC LIGHT SIGNAL TURNED GREEN, THE CAR IN FRONT MOVED AND I RELEASED THE HANDBRAKE AND INCHED FORWARD WHEN A VAN THAT CAME FROM THE RIGHT SIDE SUDDENLY CUT INTO MY PATH TO TURN LEFT INTO BELILIOS ROAD. I HORNED AT THE VAN TO STOP. THE THIRD PARTY DRIVER, MUHAMMAD ANDI BIN MOHAMED RATHI, THEN STOPPED THE VAN TO EXCHANGE PARTICULARS AND ACCESS THE DAMAGES. 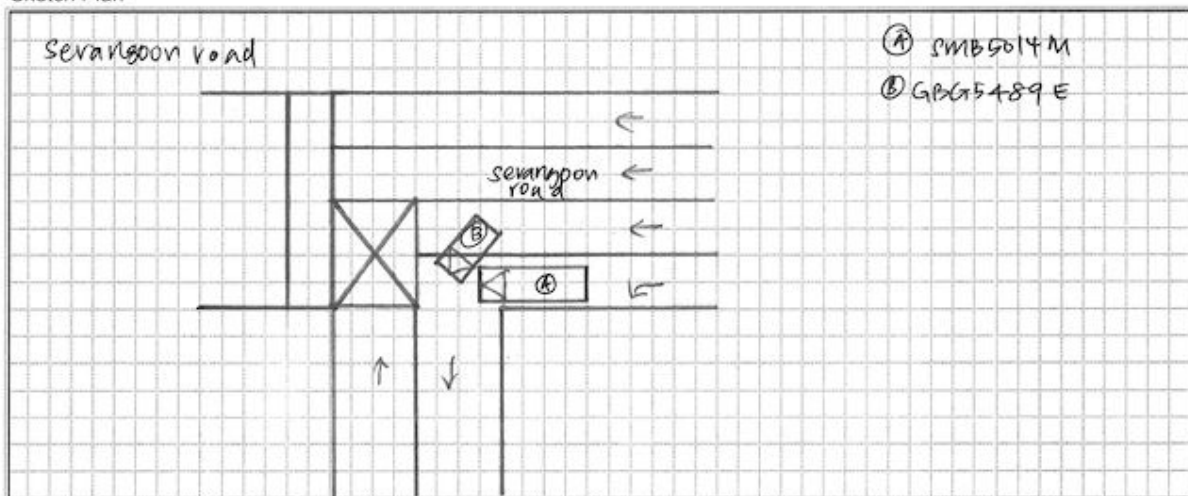
