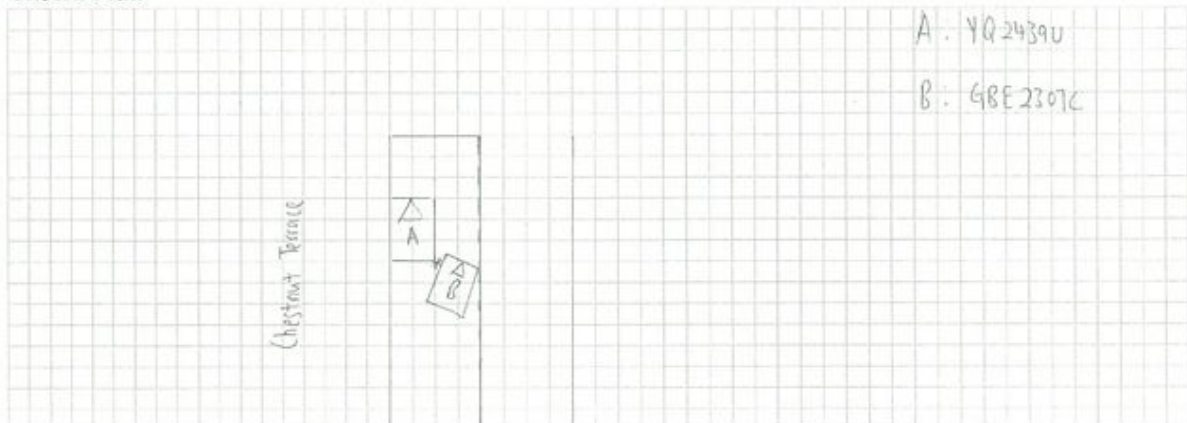

Sketch Plan

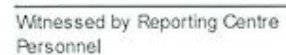

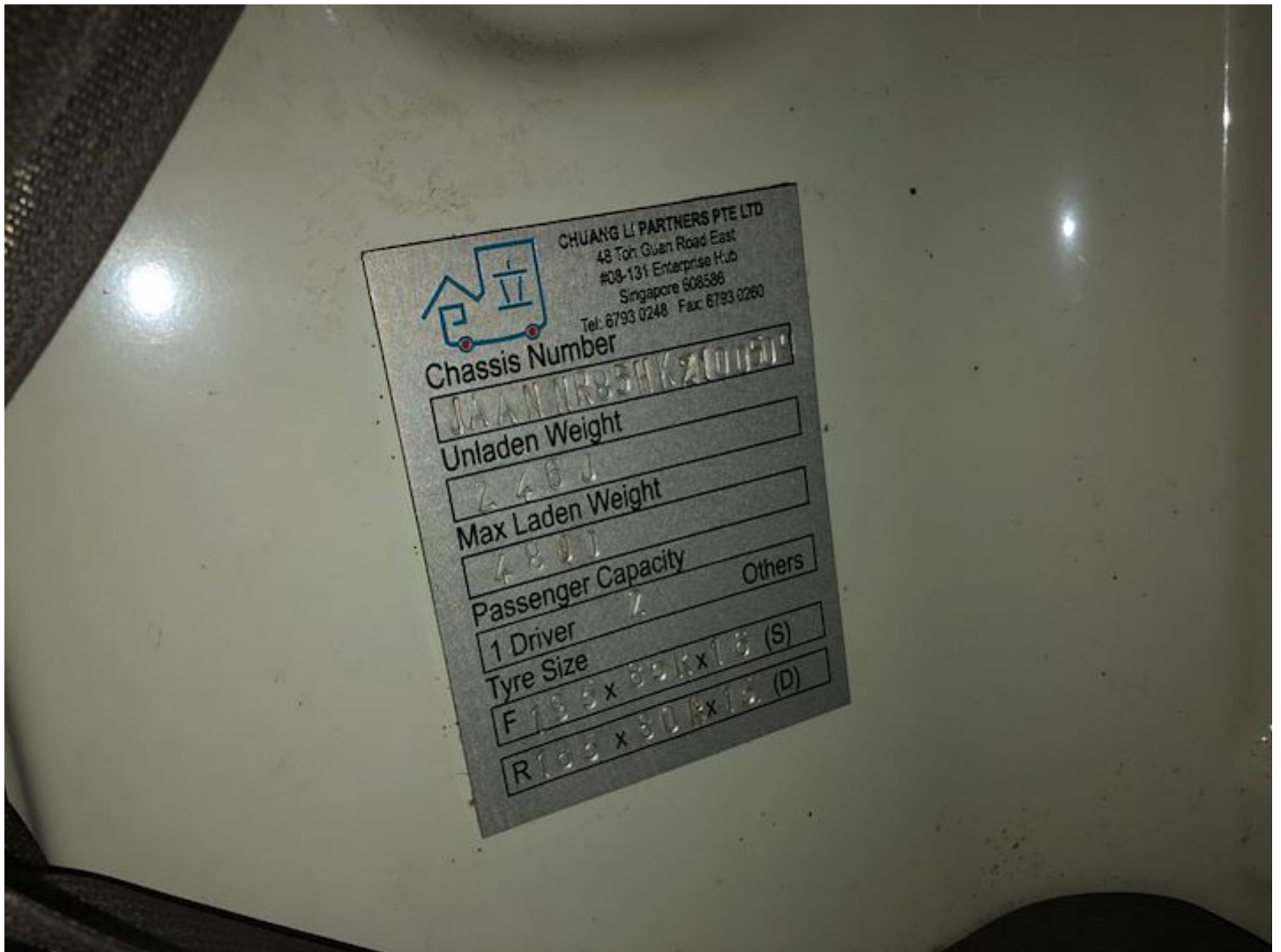

Brief Details.

At the said time, I had parked my vehicle at 2 Chestnut Avenue to wait for my workers on the roadside, with hazard light on. The road was also observed to be busy as there were a lot of cars parked at the roadside.

Subsequently I saw a van bearing plate number (GBE2307C) had tried to squeeze in between my vehicle and the vehicle on the right. Right before I move off, the said vehicle squeezed and subsequently collided to my vehicle. My vehicle did not sustain any damages however the other vehicle sustained minor dents on the left passenger door.

There were no injuries reported, no government property damaged.

I am lodging this report for record and insurance purposes only. The other party had agreed to settle the matter privately.
