I am working for Bee Huat Credit Pte Ltd located at Blk 343 Jurong East S1 31 #02-61 Tel: 65686885. I am working as a freelance sale and repossession. I am making this report on behalf of my company

I have a friend namely Looi Stew Kong NRIC: S2057896C Blk 681 Hougang Ave 8 #04-B11 S(530681). He is the owner of car SFV3161L. His car is still under finance of my company.

On 4/7/2023, my friend passed away at Sengkang Hospital. On 5/7/2023 when I went to the funeral wake, his wife passed the car key to me. I went over to make a check on the car which was parked at the HDB open carpark of Blk 681 Hougang Ave 8. Everything was fine. I did not drive the car and left it at the carpark so as to make the necessary arrangement.

On 11/7/2023 when I came to get the car, I discovered some damages to the car. The front bumper including the number plate were dented in and the front left portion near the tyre was also dented. I also saw that a note was left behind on the front windscreen. The note was signed off by a 'Jessica HP: 81256595' who admitted to have accidentally reversed into the car while parking. When I contacted Jessica, she told me that the accident happened on the morning of 9/7/2023.

After checking with my company, I told her that the cost to repair was SGD\$450. She was not agreeable and only offered to pay SGD\$300. She also mentioned that she would need to check with her father and her mechanic. When I told her that the car owner had recently passed away, she then mentioned that she is now willing to pay only SGD\$200. If I am not agreeable, I can make a report on this matter.
