Around the above specified time, i.e. 4:55 pm, 22 July 2023, after I riding my bike exited from PIE to Eng Neo Ave. travelling south bound on the right lane toward the junction connecting Bukit Timah/Duneam Road, at the location where a yellow No Waiting Zone (box) outside of the Orchid Apartment (42 Eng Neo Ave.)/or opposite the lamp post (No. 8/with painted words EN1002 at the curb of the opposite travelling direction side of road, a motor car (reg. no. SMV957U) collided to me riding my bike while the driver was veering it to its right where my motorcycle was travelling on. It is noted that the driver (Mr. Takahashi Kenta) of the motor car was attempting to make an U-turn at a location not allowing of such maneuver. The motor car was not standing still and waiting, it was moving and veering off to the right from the left side provided me no enough time to react, except emergency braking and shouting.

After the collision, while I was collecting myself, briefly examined my visible injury, cut/abrasion with blood

when it was torn to snapped, the driver alighted the car and concerned of my condition. After pulsing for 2 to 3 minutes not answering and thought at the time I may be ok, I mentioned "I guess that both of us are very lucky that there may not have big issues to deal with." Although, I am not sure whether he registered what did I say.

There was a lady, believed alighted from a passing by vehicle (Reg. SDK 2838G), asked whether need to call the ambulance/traffic police then she called. Based on the info. (Note: I got from the Para-Medic from the ambulance vehicle, that they got the dispatch call at around 5:00 pm, therefore I believe the incident occurred at around 4:55 pm, etc.) She may witnessed the incident. Another passing by lady, Dr Natalie, a Medical Doctor briefly inspected my injury and also helped to verify "on call 995" whether any ambulance is on the way, she suggested me to have a detail check up, although at the scene she inspected and found generally ok, except the abrasion. Dr. Natalie may also witness the incident.

While waiting for the traffic police to arrive, the ambulance arrived, the female doctor handed over her observation/finding from her inspection of me to the para-medic. As two tow vehicles' staffs suggested to move the vehicle and bike, I then started to take pictures of the scene, including the motor car and my bike involved in this incident. Noticed there were damages to my bike and the impacted condition of the

The braking mark, believed to be from my bike's tyres, left on the yellow marking material of the "no waiting zone box" indicated my travelling location on the right lane toward my travelling direction. The Traffic Police officer, Mohd Shahzan, mentioned that the driver told him his car have camcorder that may recorded the motor car's travelling dynamic/position and footage at the time of the incident and situation after the impact. The security camera at the gate of the Orchid Apartment with the lens pointing to the road may also have the footage.

My understanding is that the traffic police released my bike to my friends arrived to the scene after left to hospital, to be sent to workshop for damage assessment. The damages noticed then including, but may not limited to handle bar guards, the radiator with the guide vane flew off, my watch was broken, etc. Detail of the damage will need to be assessed by the workshop and insurance company.

I have reported to my motorbike's insurance company INCOME.

The driver of the motor car mentioned that he had reported the incident to his insurance co. and had submitted the recording footage extracted from his car to police on 22 July 2023. He texted me last on 22 July. After I told him I was discharged from hospital and he was relieved to learn that I am generally fine. He expressed his apology for my injury and property damages.
