Sketch Plan

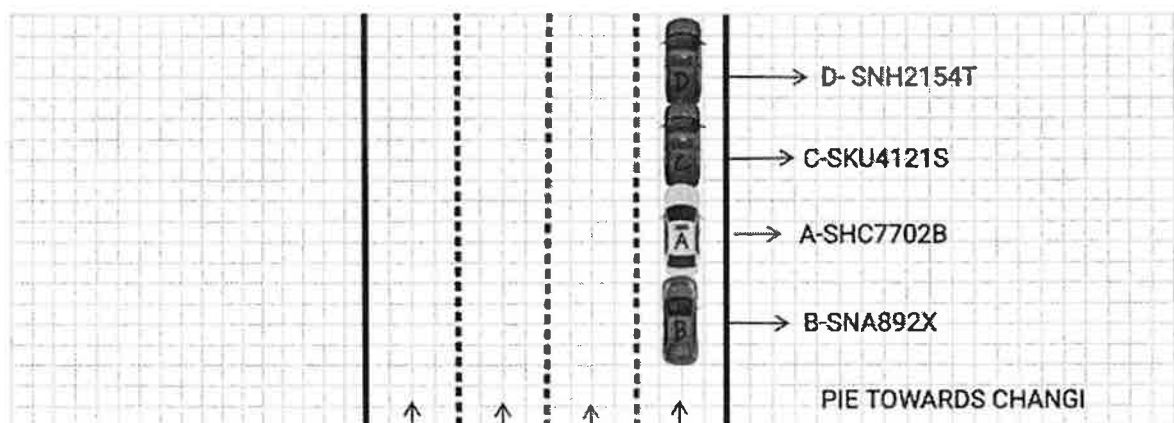
