

(F) General Description of Damages

The impact of the collision has damaged/affected the rear bumper, rear bumper lower spoiler, bumper sensor and etc.

(G) Recommendation

We have inspected thoroughly the actual damages found on the vehicle, before we arrived at our recommendation as to whether the parts needed replacement or repairs.

Our adjusted cost of lump sum repair is \$4,000.00 and an estimated 4 days is required to repair the vehicle. Please refer to the Annex for a detailed account of the cost estimates.

(H) Remarks

We have not authorized the repairs. However for information, under normal circumstances, the repairs should not exceed $\underline{\mathbf{4}}$ days.

This inspection was conducted on a "without prejudice" basis.
