

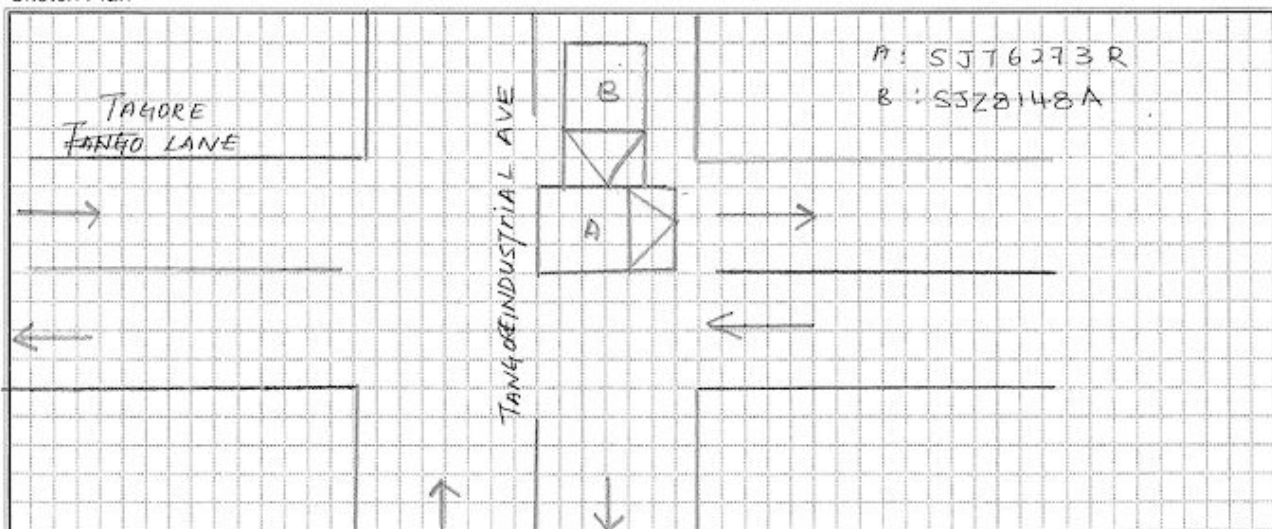

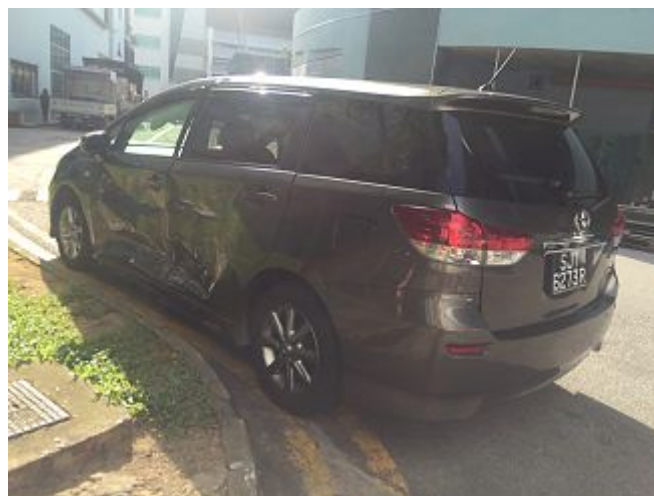

## Sketch Plan



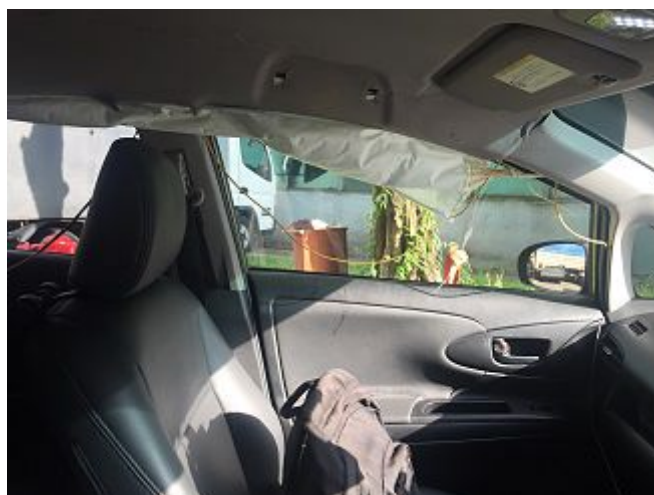
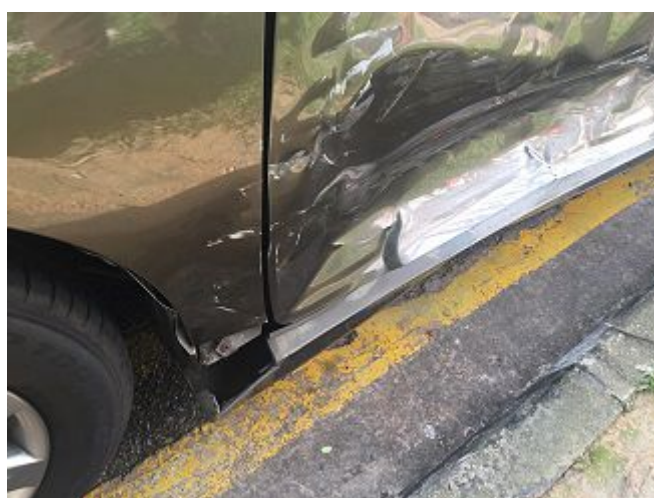
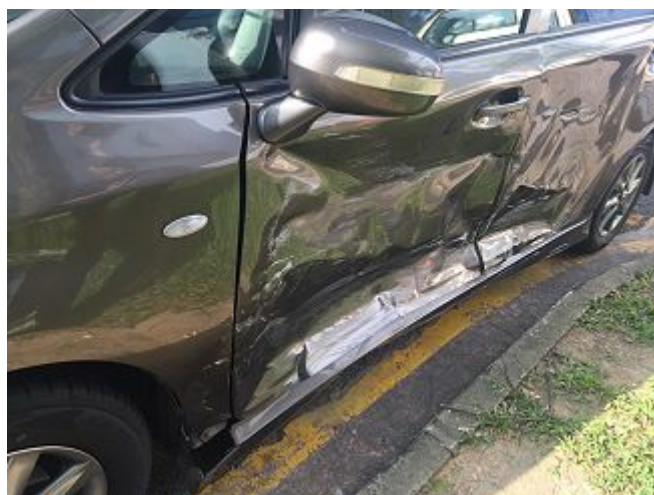
