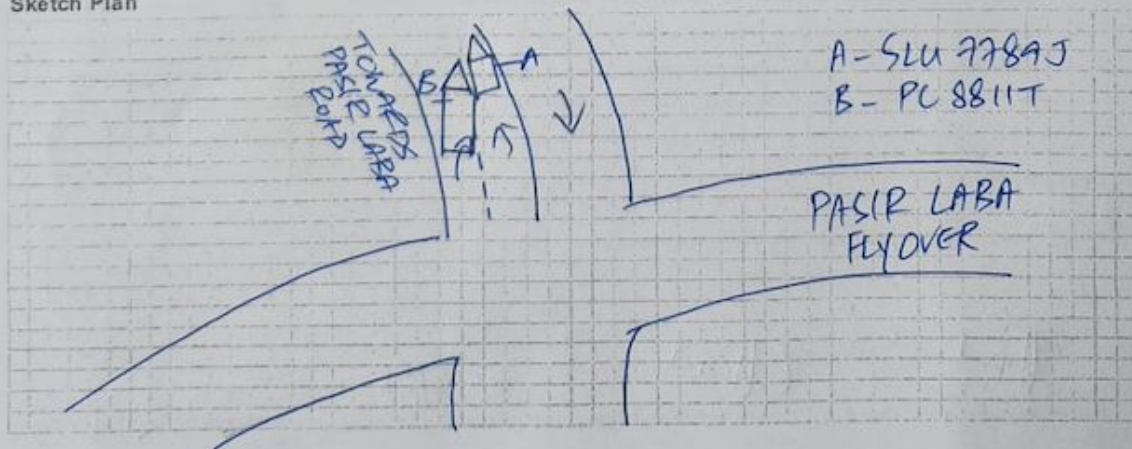

ON 26/5/23 @ ABOUT 8:45AM, I WAS TRAVELLING UNDER PASIR LABA FLYOVER, GOING TOWARDS PASIR LABA ROAD, IN MY VEHICLE SLU77895. AS I ENTERED THE MERGING LANE, BUS VEHICLE PC 8811T SUDDENLY CUT ONTO MY LANE FROM THE LEFT & COLLIDED ONTO MY VEHICLE'S LH PORTION. THE IMPACT THEN PUSHED MY VEHICLE TO HIT THE DIVIDER KERB, CAUSING DAMAGES TO MY VEHICLE'S RH LOWER PORTION, TYRE & RIM.
