SKETCH PLAN

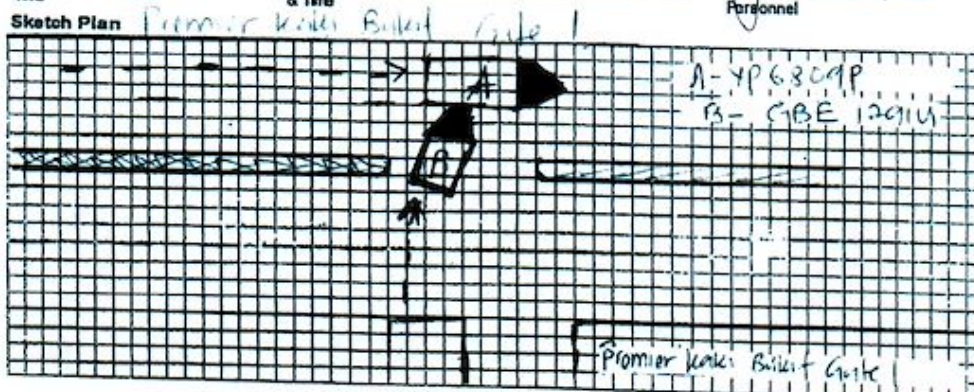


The Circumstance of the Accident
