Mr. Gwee Chun Guan visited our clinic on 5<sup>th</sup> May 2023 with an injury on both palm and right kneecap (superficial abrasion wounds). He was involved in a motor vehicle accident on the same day. There were no other serious complaints like the head injury. A thorough medical examination was performed in the clinic and showed no serious injury and nil neurological deficit.
